Item #1. To adopt the Budget of the Board of Education in the amount of \$8,474,689 as approved by the Board of Finance and to appropriate said sums of monies for Fiscal Year Ending June 30, 2026.

Item #2. To adopt the Budget of the Board of Selectmen in the amount of \$3,226,522 as approved by the Board of Finance and to appropriate said sums of monies for Fiscal Year Ending June 30, 2026.

Item #3. To adopt the Sterling Local Capital Improvement Plan (current & projected five-year plan) in the amount of \$59,913 as approved by the Board of Finance and to appropriate said sums of monies for Fiscal Year Ending June 30, 2026.


